PURPOSE OF THE APPLICATION:

To alter a two-storey detached dwelling by completing interior alterations and by constructing a rear two-storey addition , a front porch and a rear deck

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. Chapter 10.40.40.70.(3) (A), By-law 569-2013**
The minimum required side yard setback is 0.9 m.
The side yard setback will be 0.13 m on the west side and 0.37 m on the east side.
- 2. Chapter 10.40.40.40.(1) (A), By-law 569-2013**
The maximum permitted floor space index is 0.75 times the area of the lot (94.57 m²).
The floor space index will be 0.93 times the area of the lot (117.8 m²).
- 3. Chapter 10.40.30.40.(1), By-law 569-2013**
The maximum permitted lot coverage is 35% of the lot area (44.13 m²).
The lot coverage will be 48% of the lot area (60.12 m²).
- 1. Section 7.5.3, By-law 6752**
The minimum required west side yard setback is 0.45 m.
The west side yard setback will be 0.13 m.

2. Section 7.5.3, By-law 6752

The minimum required east side yard setback is 0.45 m.
The east side yard setback will be 0.37 m.

3. Section 7.5.3, By-law 6752

The maximum permitted lot coverage is 35% of the lot area (44.13 m²).
The lot coverage will be 48% of the lot area (60.12 m²).

4. Section 7.5.3, By-law 6752

The maximum permitted floor space index is 0.75 times the lot area (94.57 m²).
The floor space index will be 0.93 times the lot area (117.8 m²).

THE COMMITTEE OF ADJUSTMENT & MINOR VARIANCES

- the variance requested is minor;
- the proposal is desirable for the appropriate development or use of the land and/or building;
- the general intent and purpose of the City's Zoning Code and/or By-law are maintained; and
- the general intent and purpose of the Official Plan are maintained.

The Committee of Adjustment forms its opinion through its detailed review of all material filed with an application, letters received, deputations made at the public hearing and results of site inspections.

The notice has been mailed to you, as required by the *Planning Act*, to ensure that, as an interested person, you may make your views known by:

- **Attending the Public Hearing.** Attendant Care Services can be made available with some advance notice.
- **Sending a letter by Mail, E-mail, or Fax.** Information you choose to disclose in your correspondence will be used to receive your views on the relevant issue(s) to enable the Committee to make its decision on this matter. This information will become part of the public record.

If you do not attend the public hearing, or express your views in writing, the Committee may make a decision in your absence, and may recommend changes to the proposal

- If you wish to appeal a Decision of the Committee to the Ontario Municipal Board, you must file your written request for a decision with the Deputy Secretary-Treasurer.
